

As of September 16, 2025, the Warren County Board of Supervisors have moved all funds appropriated for Library Services to other county departments.

# TRANSPARENCY

An example of transparency is providing <u>access to public meeting minutes</u> and <u>financial data online through a civic web portal</u>, allowing them to understand how decisions are made and how funds are spent.



"In general, exempt organizations must make available for public inspection certain annual returns and applications for exemption, and must provide copies of such returns and applications to individuals who request them."

# Who Holds Nonprofit Boards Accountable?

# ACCOUNTABILITY

# **State and Federal Authorities:**

- Warren County Board of Supervisors Voting Representative at Library Meetings, Annual Budget Request Process, Mid and Year-End Reports and Performance Measurements, MOA compliance.
- IRS: Governs nonprofits for tax-exempt status and requires annual reporting, such as Form 990, to ensure legal compliance and accountability.
- State of Virginia Compliance with reporting and requirements for funding
- State Attorneys General and Charity Officials: Oversee charities within their states to ensure they are operating legally and in the best interest of the public.

# **Internal Board Responsibilities:**

- The Trustees are a volunteer, governing board responsible for its own actions and must ensure that the organization follows laws, acts ethically, is transparent, and achieves its mission.
- Finance/Investment Committee: Evaluates external auditors, presents findings to the board, and ensures that recommendations for financial improvement are implemented.

#### **Public and Stakeholders:**

- The Public: Through public scrutiny and social media, patrons and residents increasingly hold nonprofits accountable for their mission and values.
- Donors and Beneficiaries: As the ultimate stakeholders, donors and the people the library serves expect transparency and responsible stewardship of resources.





#### Conclusion

- Tonight's vote is merely opting out of an automatic contract renewal, preserving options for the county.
- Warren County taxpayers have a rightful expectation that public services paid for with public funds should be under the oversight of public library board.
- There will not be 1 second of time in Warren County when public library services are not funded. Claims of defunding the library are aimed at creating alarm and turmoil.


